

1 | INTRODUCTION

NAGA Pay GmbH (hereinafter referred to as "NAGA Pay" or "Company"), which is an entity duly incorporated under the laws of Germany, offers the following Competition to its users subject to the Terms and Conditions contained herein.

NAGA Pay is running this "APOEL VIP Experience "Competition (the "Competition") and invites all its new and existing users to participate. By registering and participating in the Competition, you agree to be bound by the Terms and Conditions (the "Terms") set out below.

By accepting to participate in this Competition, the present Terms and Conditions as well as the Company's Terms and Conditions and all the other legal documents which are accessible anytime by everyone through the Company's website, namely https://pay.naga.com/, are binding to the user.

2 WHO CAN PARTICIPATE

Eligibility:

- 1. To be eligible to participate in the Competition, you must have:
 - (a) Review, Understand and Accept the present Terms and Conditions along with the other legal documents of the Company, which are always publicly available on the website of the Company.
 - (b) Successfully complete the registration process in the period beginning on 19/04/2023 and ending on 27/04/2023 at 23:59 EET.
 - (c) Properly register an approved account with full KYC documents in place (i.e. a proof of identity and a proof of residency) until 28/04/2023 at 12:00 EET, or have an already approved account.
 - (d) Follow the steps on Instagram (www.instagram.com) and/or Facebook www.facebook.com (as explained below).

Steps to be followed:

B. Facebook

- i. Like the page of @nagapayapp.
- ii. Like the competition post.
- iii. Tag 2 friends in the comment section.
- Download the app at https://pay.naga.com/ and complete your free NAGA Pay iv. registration. (This step does not apply to existing Naga Pay users)

Each participant is allowed for 1 entry in the Competition, either on Facebook or Instagram. If a participant enters the Competition with more than once on either platform, the Company will take into consideration the first chronological entry of that Participant.

2. NAGA Pay shall have sole and absolute discretion in determining whether the reward can be awarded to you.

4 GENERAL

Such amendment will become effective on the date specified in the notice. Unless otherwise agreed, an amendment will not affect any outstanding order or transaction or any legal rights or obligations which may already have arisen.
- The Company reserves the right to modify or cancel this Competition at any time and at its sole discretion or cease this Competition without any prior notice.
- 4. This Competition shall start on 19/04/2023 and end on 27/04/2023 (inclusive).
- 5. The draw will take place on the 28th of April at the offices of NAGA Pay.
- 6. Winners will be contacted via email and phone.
- 7. This is a cross platform competition. There will be a total of 5 winners from both Facebook and Instagram.
- 8. The Competition may be revoked or withdrawn for participants who abuse the spirit or intention of it, or for participants who are suspected of abuse of the Competition.
