

### 1 | INTRODUCTION

NAGA Pay GmbH (hereinafter referred to as "NAGA Pay" or "Company"), which is an entity duly incorporated under the laws of Germany, offers the following Promotion to its users subject to the Terms and Conditions contained herein.

NAGA is running this Promotion (the "Promotion") and invites all its new and existing users residing in Cyprus to register. By registering and participating in the Promotion, you agree to be bound by the Terms and Conditions (the "Terms") set out below.
